Community Comment Alva (Producer)	Alva: Safe Harbor Hour Live broadcasts/cablecasts – Producers have been asking for this for years. Please include this in re-opening plans. Would like to host a live music jam show on Mondays (10-11pm) when musicians are available. Would like the ability to livestream on live channels, via cablecast live, also so people can come in via Zoom. Are cable drops still available? Might be cheaper to do it via an internet connection This would extend the OBS training. What is the status of being able to livestream from the multi camera unit? Elisa: thanks for bringing this up. Let's follow up together on these fronts!	
Community Comment	Jim: Concerned about the use of an application process to enter a cohort – will this be exclusionary? Will this reduce the training? Would the current, knowledgeable producers be able to help expand opportunities for training? Studio training and field training were both helpful in working on others' shows and in producing their own. Now that a full project is required as part of applying to train, that approach takes the opportunity for training away from those who wish to only train and work on others' projects Elisa: we've chosen the application process to ensure that the folks outlined in our grants agreement get the opportunity to get access to services. It achieves that more than the first come/first served approach we've used in the past. Loves his idea about producers volunteering to train folks – all producers are welcome to do that. Our series producers can get access to	

equipment by filing out an application, to present a project ahead of time (and also identify themselves as members of those groups identified in our grants agreement if that's applicable.) People who just want to train (not create a project) – new camera kits will be available for them. Studio classes will be more led by community members – should free up the studio time. As we roll out our new procedures, and talk about them at the member meetup, let's discuss more – we're likely on a similar page. Handelman: Please consider a Board retreat hybrid event. Flying Focus got a MHCRC grant. Community wants to have input on bylaws – can community/producers have access to comment while the legal response is pending? Member meetup interface that presents project was frustrating because you couldn't call in via phone to participate in the video portion.
